The price is set according to the minimum committed volume and is only valid for 2022. Should Tricorona not order 40 tons in 2022, Climeworks reserves the right to adapt the prices up to a maximum amount of 1000 €. New terms and conditions shall be agreed upon for 2023.

Tricorona grants Climeworks the right to use Tricorona's logo. Tricorona shall provide Climeworks with its logo in a form suitable for website/app and print publication.

Tricorona shall promote Climeworks' CDR Services to its audience/customer base in accordance with the messaging guidelines included in the Pioneers communication kit provided by Climeworks.

Tricorona shall in summary form keep Climeworks updated in writing (e-mail is sufficient) as regards all planned communication activity relating to or referring to Climeworks' CDR Services.

Except as provided in the paragraphs above, the Parties shall keep the terms of this agreement confidential and shall not disclose it to any third party. Climeworks shall be entitled to disclose the existence and terms of this agreement to potential or current partners or investors.
